**This bicycle is rented subject to the following conditions:**

1. The cycle shall only be used by the person whose name appears on the contract (hereinafter called the Lessee) and shall be returned promptly at the expiration of the time indicated hereon.
2. The rental period will not terminate until the cycle is returned to the Lessor.
3. The Lessee shall be liable for any damage to the cycle during the rental period or for the loss of said cycle by theft during the rental period. Bring the bike back in the condition you received it. **An excessively dirty or muddy bike will incur a detailing charge of \$40.**
4. For safety reasons the lessee acknowledges that he or she should wear a helmet while riding, and that riding a bicycle can be inherently dangerous. The lessee further agrees to operate the cycle in accordance with all the motor vehicle regulations of the state of Ohio.
5. Lessee acknowledges that he or she has received adequate instructions in the operation of the cycle upon request, including but not limited to, the controls, brakes, and starting and stopping. Lessee further acknowledges that he or she has examined the cycle prior to executing this contract and that it is in good working order
6. Neither the Lessor or the Owner of the cycle shall be liable for any loss, damage, or expense resulting from the acts or omissions of the Lessee or any other person, and the Lessee agrees to indemnify and save harmless the Lessor and/or Owner from any loss, damage, or expense, including reasonable attorney's fees, incurred by the Lessor and/or Owner in connection with this agreement
7. If you're the kind of person who blames everything that happens in their life on someone else, don't rent this bike. Our intention is for you to have fun while riding, and to that end wear a helmet, enjoy yourself, and please be careful.
